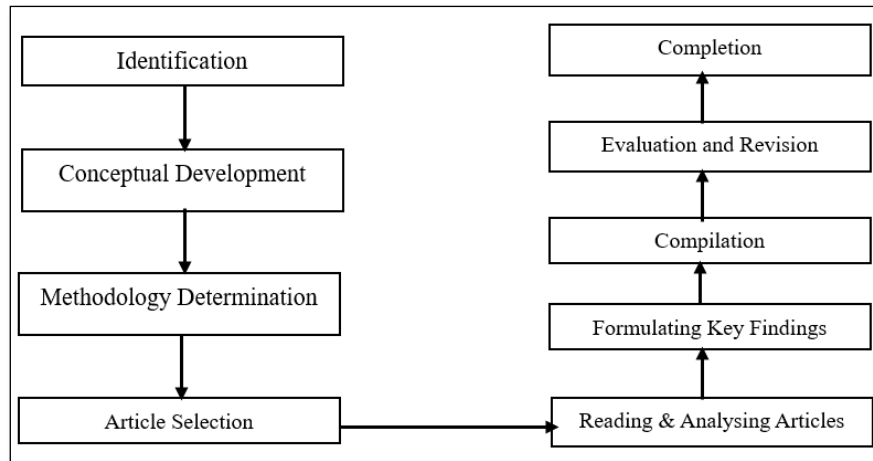


Figure 1. Research Flowchart
